WORTH VALLEY LINE, Councillor Hammond, the Mayor of Keighley, is pressing for improved services on the "orth Valley Line. Will all members who can give Councillor Hammond support in this, please endeavour to do so. Lambourn Valley Branch. We have received an account of a meeting held by local residents, at which a representative of British Railways was present. The annual loss on this branch is stated to be £19.464, but no analysis at all was given of how this figure was made up. A census was taken on two different days of the traffic between Lambourn and Newbury; the first one was by bus on a busy weekday, and the second was on a day of very light traffic in November last. It appears likely that the bus census was taken on Market Day, and the Rail census probably on early closing day, and being in Movember, in all probability when it It was estimated at the meeting that if a diesel were used, the was foggy! annual loss would be reduced by over £15,000 to £4,000; and if several intermediate stations were closed, the line would pay its way. It should be noted in passing. however, that the last departure from Newbury is at 5:20 pm; and that the 3:10 pm from Paddington fails to connect by only 6 minutes. In addition, there used to be a departure until the middle of last summer at 7:20 pm which connected with the 6:0 pm from Paddington; many business men (mainly first class) travelled down by this train, and it would appear a very short sighted policy to have The meeting ended with passing a resolution withdrawn this particular service. that it felt there was a good case for the retention of this route,
